Sealed Bids for the construction of the **Saginaw Charter Township Wastewater Treatment Plant 0.6 MGD Expansion** will be received, by **Saginaw Charter Township** at the office of **Saginaw Charter Township Department of Public Works** located at **4870 Shattuck Rd, Saginaw, MI 48603** until **10:00 A.M.** local time **on May 31, 2024** at which time the Bids received will be publicly opened and read. The Project consists of the following:

- A new Headworks Building with metering, sampling, screening, and grit removal,
- Two (2) 55' diameter concrete primary clarifiers,
- A primary sludge pump station/stormwater station with grinders, rotary lobe pumps, submersible pumps,
- A new concrete 2.4 MG oxidation ditch with vertical aerators and a building,
- A new 55' diameter concrete secondary digester tank with cover, gas handling equipment and an attached building.
- Replacing a digester cover on an existing 35' diameter tank, handrails, existing building modifications and gas handling equipment,
- An addition to the existing electrical building,
- Replacement of final effluent and chlorinated effluent pumps,
- Sludge handling facilities including a heat exchanger, boiler, grinders, sludge transfer pump, p
- Piping, valves, gates, stairs, grating, manholes, catch basins, bypass pumping, hvac,
- Electrical, instrumentation and controls,
- Minor demolition and removals of existing piping, equipment and modifications to existing structures and buildings.
- A new gas service and an electrical service upgrade from Consumers Energy,
- Sitework including asphalt paving, concrete sidewalks, site lighting, grading and restoration.

The Owner reserves the right to waive informality in any bid, to reject any or all bids, or accept any bid which is considered most favorable to the Owner. Each proposal shall be accompanied by certified check or bidder's bond in the amount of 5% of the bid. Checks shall be drawn payable to SAGINAW CHARTER TOWNSHIP as security for the acceptance of the Contract and subject to the conditions stated in the Instructions to Bidders.
