

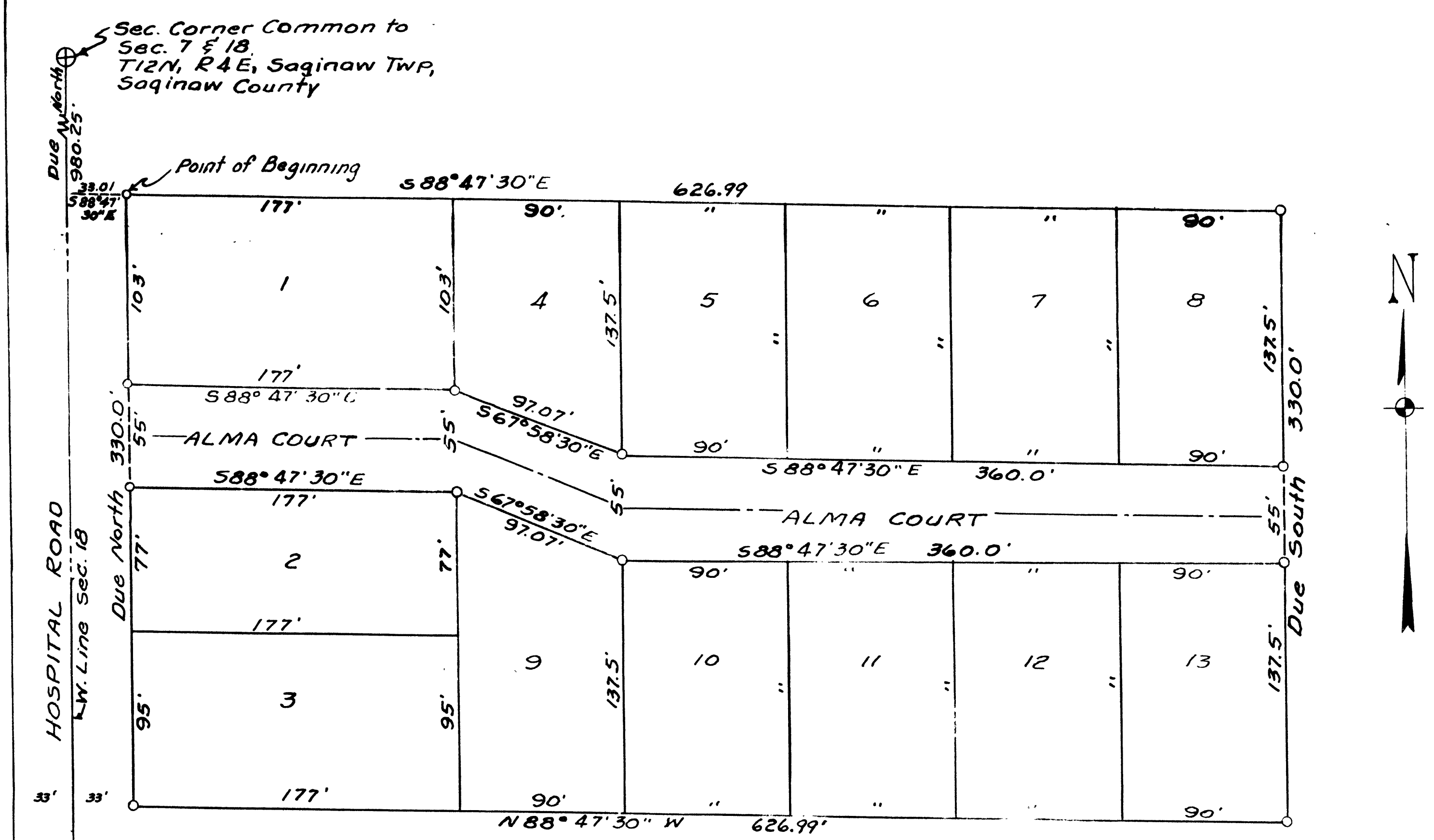
ALMA COURT SUBDIVISION

DEDICATION

KNOW ALL MEN BY THESE PRESENTS, that we, Alexander Shabluk and Mary Ann Shabluk, his wife, and Mike Shabluk and Mary Shabluk, his wife, and the Michigan National Bank, Mortgagee, as proprietors, have caused the land embraced in the annexed plat to be surveyed, laid out and platted, to be known as ALMA COURT SUBDIVISION, being the W. 660' of the W. 31.56 Acres of the N. 63.12 Acres of the N.W. Fr. 1/4, Sec. 18, T. 12 N., R. 4 E., Saginaw Township, Saginaw County, Michigan, and that the court as shown on said plat are hereby dedicated to the use of the public.

DESCRIPTION OF LAND PLATTED

The land embraced in the annexed plat of ALMA COURT SUBDIVISION, being the W. 660' of the W. 31.56 Acres of the N. 63.12 Acres of the N.W. Fr. 1/4, Sec. 18, T. 12 N., R. 4 E., Saginaw Township, Saginaw County, is described as follows: Commencing at the Sec. corner Common to Sec. 7, 8, 17 and 18, thence Due S. 980.25' along the W. line of Sec. 18, thence S. 88° 47' 30" E. 33.01' to the point of Beginning. Thence S. 88° 47' 30" E. 626.99', thence Due S. 330.00', thence N. 88° 47' 30" W. 626.99', thence Due N. 330.00' to the point of beginning.
