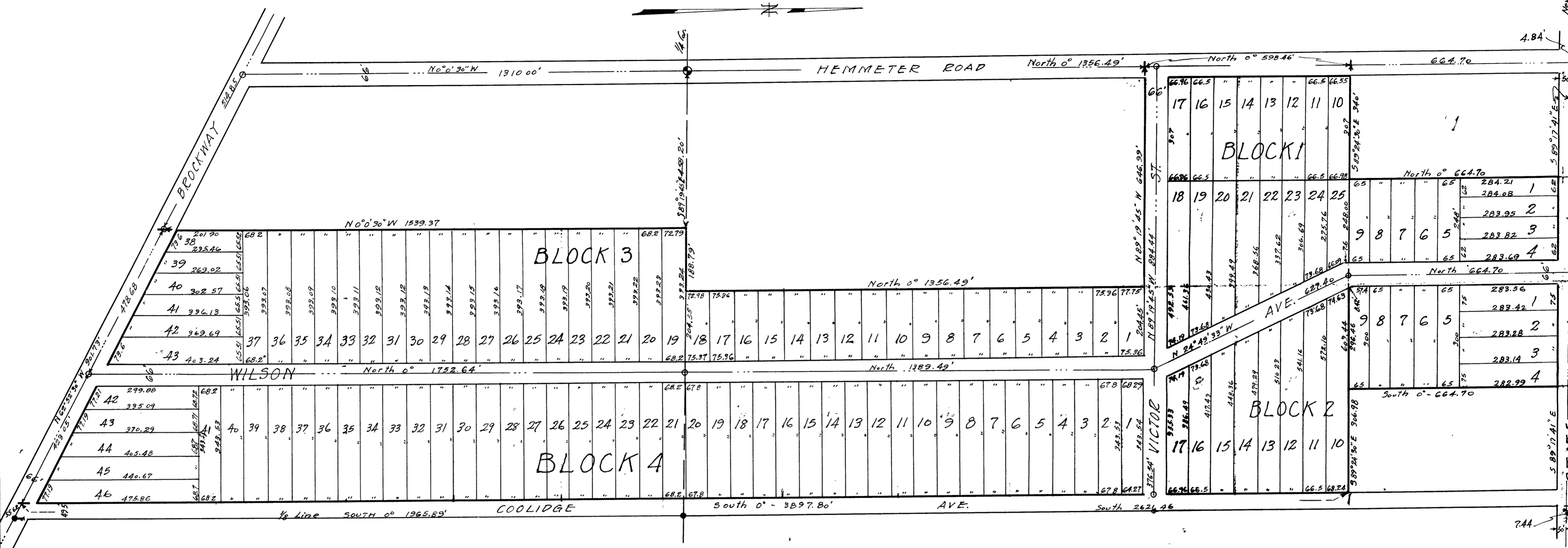

DESCRIPTION of LAND PLATTED

The land embraced in the annexed plat of Homewood is replat of lots 2, 3, 5, 6, 8, 9, 12, 13, 16, 17, 18, 19, 20, 21, 22, 23 and N 265.94' of lot 7 in P.O. Johnson's Add. to the City of Saginaw, Saginaw Twp. Sec. 21, T12 N, R4 E of Saginaw Co. Said land being more fully described as follows; beginning at a point on the N. line of Sec. 21 340' E. of the N 1/4 Cor. of said Sec., running thence along said N. line S89°24'30" E 614', thence S. 0°, 664.70', thence S89°24'30" E - 306.98' thence S. 0° - 3897.80' to E. of Brockway, thence along said E. N 62°52'30" W 901.73', thence N 0°30' W 1339.37' to the E. W. 1/4 line thence along said 1/4 line S89°19'45" E - 188.79', thence N. 0°1356.4' thence N 89°19'45" W - 646.99' to the N. 1/4 line, thence N 0° 598.46' along said 1/4 line, thence S89°24'30" E 340', then N 0° - 664.70' to point of beg.
