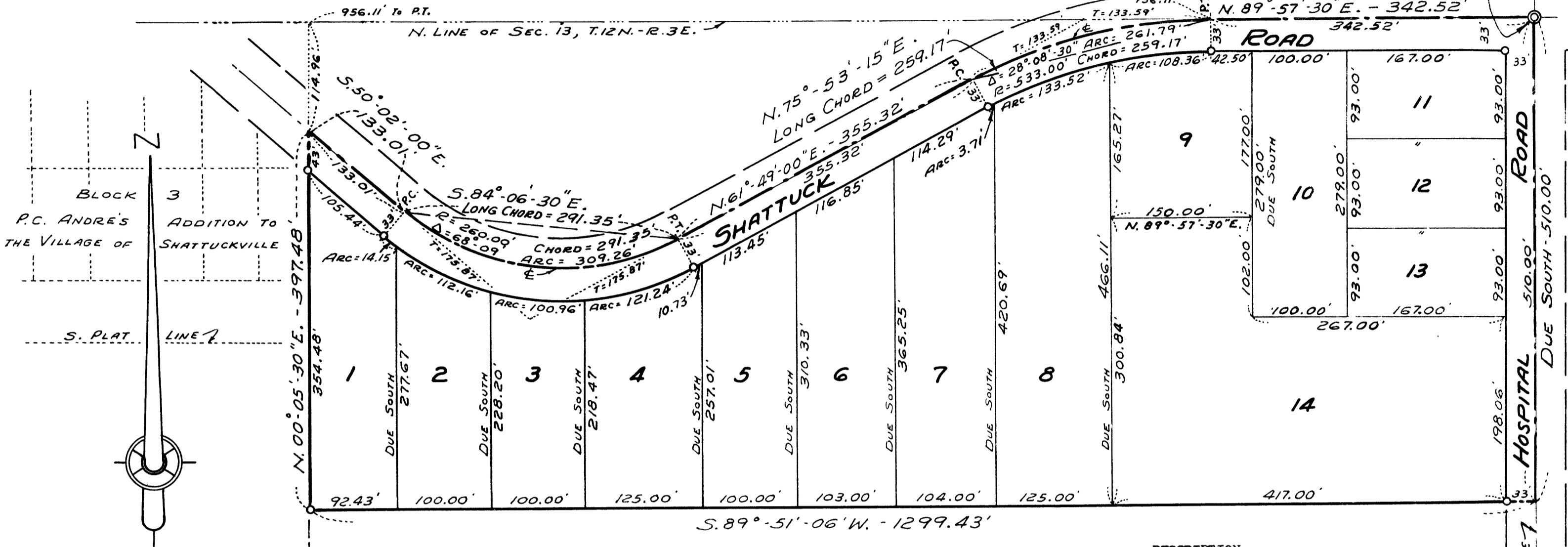

### DESCRIPTION

The land embraced in the annexed plat of REINKE PLAT, A Part Of N.E. 1/4 Of Section 13, T.12 N.-R.3 E., Saginaw Township - Saginaw County - Michigan, is described as follows: Commencing at the Northeast corner of said Section 13; thence Due South along the East line of said Section, 510.00 feet; thence S.89°-51'-06"W., 1299.43 feet; thence N.00°-05'-30"E., 397.48 feet to the centerline of Shattuck Road; thence S.50°-02'-00"E., along the centerline of Shattuck Road 133.01 feet to the point of curvature of a curve to the left having a centerline radius of 260.00 feet; thence Easterly along the arc of said curve 309.26 feet to the point of tangency of said curve whose long chord bears S.84°-06'-30"E., 291.35 feet; thence continuing along the centerline of Shattuck Road N.61°-49'-00"E., 355.32 feet to the point of curvature of a curve to the right having a radius of 533.00 feet; thence Easterly along the arc of said curve 261.79 feet to the point of tangency of said curve whose long chord bears N.75°-53'-15"E., 259.17 feet; thence N.89°-57'-30"E., along the centerline of Shattuck Road and the North line of said Section 13, 342.52 feet to the point of beginning. This plat contains 14 Lots numbered consecutively from 1 to 14 inclusive.
