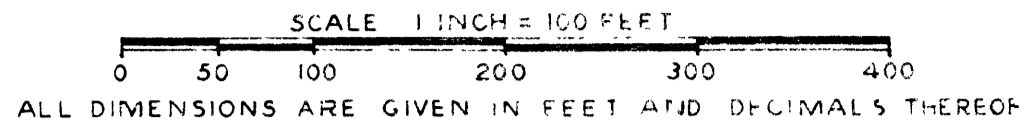
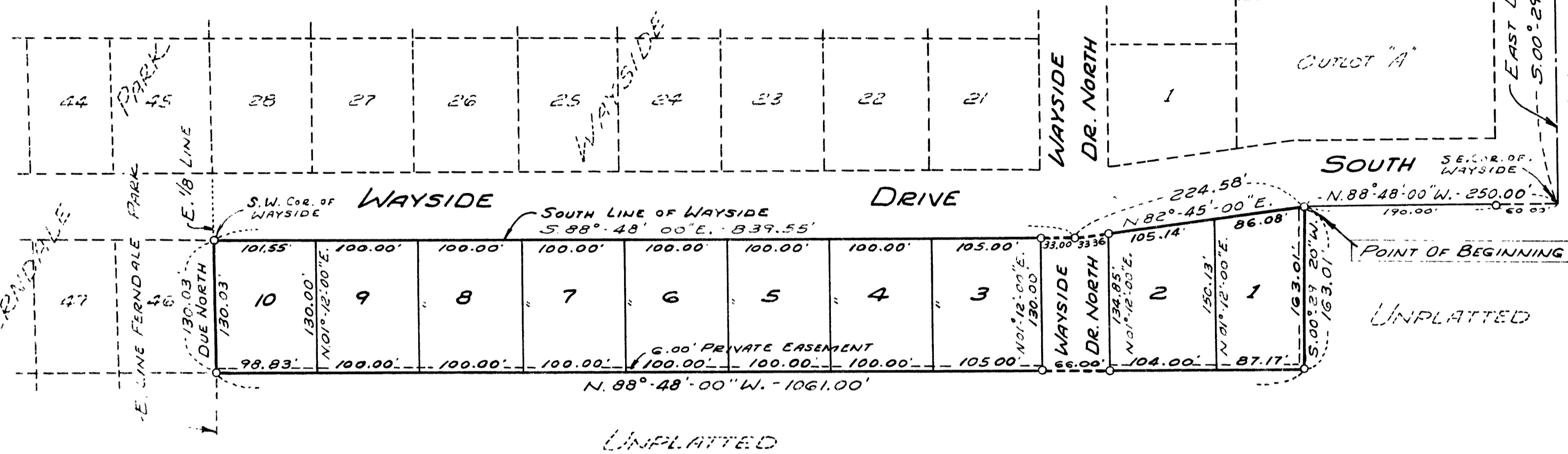
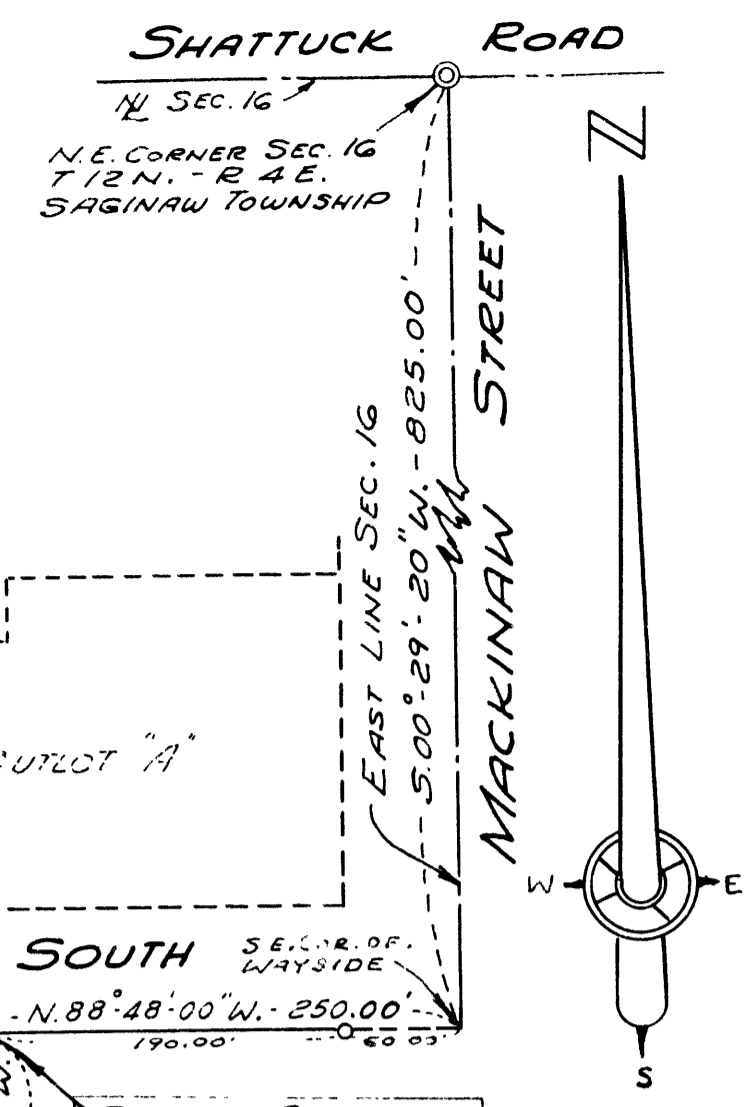

DESCRIPTION

The land embraced in the annexed plat of WORTHINGTON HEIGHTS, Section 16, Township 12 North, Range 4 East, Saginaw Township, Saginaw County, Michigan, is described as follows: To fix the point of beginning commence at the Northeast corner of said Section 16; thence S.00°-29'-20"W., on the East line of Section 16, 825.00 feet to the Southeast corner of the recorded plat of Wayside; thence N.88°-48'-00"W., on the South line of Wayside, 250.00 feet to the point of beginning of this description; thence S.00°-29'-20"W., parallel to the East line of Section 16, 163.01 feet; thence N.88°-48'-00"W., 1,061.00 feet to the East line of the Ferndale Park and the East 1/8 line of Section 16; thence Due North, on said 1/8 line, 130.03 feet to the Southwest corner of Wayside; thence S.88°-48'-00"E., on the South line of Wayside, 839.55 feet to a deflection point; thence N.82°-45'-00"E., continuing on the Southerly line of Wayside, 224.58 feet to the point of beginning. This plat contains 10 Lots numbered consecutively from 1 to 10 inclusive.
