

# STATE OF THE ARTS EXHIBITION 2019

**JUROR:** The Art Juror for this year's Exhibition is Randal Crawford, Professor of Art at Delta College. Randal holds a MFA in fibers from Cranbrook Academy of Art (1987) and a BFA in fibers from Philadelphia College of Art (1984). He also attended the Graduate Studies Program at Banff Center School in Alberta, Canada (1985). Professor Crawford continues his education through numerous national and international conferences, ENCA Clay Conference, Photoshop World's, Design Educators Summits and most recently studied Encaustic Painting at The New York Studio School. Randal has had numerous one-person shows throughout the nation. His original and innovative art is a part of private, corporate, and institutional permanent collections such as Dow Corning Corporation, Hemlock Semi-Conductor, Palm Beach International Airport, Motorola International, Team One Credit Union, The Saginaw Art Museum, Temple Theatre and Northwood University. Professor Crawford has given many academic presentations as a guest artist, keynote speaker or discussion leader.

**AWARDS:** Awards will include a \$500 Best of Show, several \$250-\$300 Special Merit Awards, \$300 Juror Award, \$100 Peoples Choice Award, \$500 Purchase Awards, and \$75 Honorable Mention Awards.

**ELIGIBILITY REQUIREMENTS:**

- 1) Must be a Michigan artist 18 years of age or older.
- 2) Must be original work done within the past 2 years, not previously entered in this Annual Exhibit.
- 3) **Work must be submitted completely assembled.** Two-Dimensional work is to be **wired and ready to hang**. Saw-toothed hangers, etc. will NOT be accepted.
- 4) Work must be no larger than 6 ft. by 6 ft. Special handling instructions of submitted work should be noted.
- 5) All media and mixed media, painting, drawing, sculpture, works on paper, glass, fiber, ceramics, metal work, wood, etc. may be entered. **NO** Photography or Digital Imagery will be accepted.

**ENTRY PROCEDURE:**

- 1) A **registration** fee of twenty (\$20) dollars will be charged to each artist submitting art work. **Artists may submit no more than two (2) pieces of art work.**
  - ~ A check or money order of the proper amount payable to Saginaw Township, Art In Public Places, postmarked the date of deadline.
  - ~ Completed Entry Form. Make sure that: your art titles correspond in number on both cards, your medium and price of each piece listed should be filled out identical to your entry form and mailed with your check or money order.
- 2) Attach your art work's identification card to your art work. Place it on the back of the art work in the upper left hand corner.

- 3) Artists are to deliver their work, as required, to the Art In Public Places Committee at the Saginaw Township Administration Building (downstairs board room) for review by the juror, between the hours of 12-5 p.m., Friday, March 29, or Saturday, March 30, 2019. **NO ENTRIES WILL BE ACCEPTED THE DAY OF INTAKE. NO REFUNDS if unable to deliver work on these designated days.**

Accepted Works will be displayed in the Saginaw Township Admin. Bldg. and **must remain through the end of the exhibition.** A 20% commission will be taken on all sales, excluding purchase awards.
