



# Free Tax Preparation



## What to bring checklist:

- Social Security card and S.S. cards** for all dependents (NO COPIES must be original for ALL)
- Photo ID**
- Birth dates for all dependents
- W2's for wages
- Statement from DHS
- Consumers Energy bill (showing amount paid in 2017)
- Property tax bill or proof of rent paid
- Landlord's name & address
- 1099's for interest or other payments received
- 1099R pension income if retired
- SSA 1099 for Social Security income
- Last year's tax returns
- Total amount paid in daycare
- Daycare providers tax identification number
- Bank routing and account numbers for direct deposits
- Divorce/alimony documents
- Form 1095 as proof of insurance

## Volunteer Income Tax Assistance (VITA) Program:

If you are a low-to-moderate income taxpayer who cannot afford to pay for tax preparation, trained volunteers will prepare simple tax forms at the following Saginaw County VITA sites:
