IV. Plan Review Required

Plans must be submitted with the appropriate deposit before a permit can be issued, except as listed below.

Plans are not required for the following:

- One- and two-family dwellings containing not more than 3,500 square feet in calculated floor area.
- Work completed by a governmental subdivision or state agency costing less than \$15,000.00.
- Alterations and repair work determined by the plumbing official to be of a minor nature.

If work being performed is described above, check box below "Plans Not Required."

Plans are required for all other building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to 1980 PA 299 and shall bear that architect's or engineer's seal and signature.

V. Applicant Signature

Section 23a of the State Construction Code Act of 1972, 1972 PA 230, MCL 125.1523A, prohibits a person from conspiring to circumvent the licensing requirements of this state relating to persons who are to perform work on a residential building or a residential structure. VI. Homeowner Affidavit

I will cooperate with the Plumbing Inspector and assume the responsibility to arrange for necessary inspections.

VIIa. Fee Clarification

Mobile home unit site: **WHEN** item is used for sewer excavations in a new park, the permit application should include the application fee plus the number of unit sites. When setting a mobile home in a park or a mobile or modular home on private property, a permit should include the application fee, a sewer or building drain, and a water service or water distribution pipe.

VII. Fee Chart – Enter the number of items being installed, multiply by the unit price for the total fee. A separate permit is required for each unit of a multiple dwelling when such unit is served by a separate entrance.

VIII. INSTRUCTIONS FOR COMPLETING APPLICATION

GENERAL: Plumbing work shall not be started until the application for permit has been filed. All installations shall be in conformance with MI Plumbing Code. **No work shall be concealed until it has been inspected.**
 When ready for an inspection, call the inspector providing as much advance notice as possible (i.e. at least 24hrs). The inspector will need the **job location** and **permit number**.

 EXPIRATION OF PERMIT: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. **A PERMIT WILL BE CLOSED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CLOSED PERMITS CANNOT BE REFUNDED OR REINSTATED.**
