

## What To Do When Stopped Or Detained By A Law Enforcement Officer



 here have been a number of reports of recent police/citizen contacts resulting in needless,

tragic deaths. Saginaw Township Police are committed to protecting this community and it is our goal for everyone to go home safe.

Cooperating with an officer is the best way to ensure everyone's safety. Police officers are human and mistakes can be made but the street is not the place to argue or complain. When a citizen disagrees with an officer they can seek resolution in court or file a complaint with our Department afterwards.

Police will always have a reason to have contact with you; even if it is not readily apparent at the time. It is natural for people to be scared, anxious, angry or confused when stopped by the police and normal for officers to have some or all of those feelings also. Every year officers are killed or seriously injured making "routine" citizen contacts. Staying calm and being cooperative during these interactions will make the contact go smoother and get you underway quicker.

#### What reasons might I be stopped or detained?

- You look like you need assistance
- You are in the area where a crime just occurred
- You may fit the description of a suspect
- You may have violated a law unintentionally

#### What should I take into consideration when I am stopped?

- Officers may not be stopping you for the reason you think
- Over-reaction and/or lack of cooperation will complicate the situation

## **TIPS ON FLOOD SAFETY & INSURANCE**

It's time to look about your property and take preventative measures to minimize the effects of localized flooding. Here are some tips to help:

#### **Local Flooding Hazard**

The primary flood hazard areas are located within the 100-year floodplain or Special Flood Hazard Area (SFHA). In Saginaw Township, these SFHA's are generally near the Tittabawassee River. During a flood event, water elevation and velocity greatly increases.

#### **Flood Warning**

Flooding in SFHA's can be predicted in advance of it occurring, giving reasonable warning for preparation and evacuation. The National Weather Service (NWS) accesses weather and river data to determine when flood warnings will be necessary. Typically, an official warning from NWS is issued 24 hours in advance of the Tittabawassee River reaching official flood stage. When a flood watch or warning is issued, you can tune in to local radio stations 790 AM WSGW, 96.1 FM WHNN or local television station WNEM channel 5 CBS or www.weather.com online for the latest flood levels and road closures.

#### **Flood Safety**

There are a few roads and lowlying areas in Saginaw Township



that are quickly covered by water during yearly flooding events. If you come upon a "Road Closed" barricade while driving, please locate an alternate route. Most injuries and deaths in flooding events occur when unsuspecting citizens drive into flooded roadways. In as little as two feet of water, your vehicle can become buoyant. This could cause the vehicle to be swept downstream into a deeper water hazard or river.

#### **Maintain Drain Systems**

As simple as it sounds, keeping smaller drains and ditches free of debris can dramatically improve the outflow of water run-off from low-lying areas. It is illegal to dump materials into these waterways. If you observe any waterways adjacent to your property that are filled with sediment, vegetation, debris or if you see illegal dumping, please contact Saginaw County Department of Public Works at 989-790-5258 or the Saginaw County Road Commission at (989) 752-6140 to report any concerns with drains.

#### Flood Hazard Maps & Floodplain Determinations

The Saginaw Township Community Development Department (CDD) maintains copies of Flood Insurance Rate Maps (FIRM) for SFHA's in Saginaw Township. You can view the most recent FIRM's at Saginaw Township Hall at 4980 Shattuck Road in the CDD. The CDD maintains a record of received elevation certificates, as well.

#### **Flood Insurance**

According to the National Flood Insurance Program (NFIP) a home located within the SFHA has a 26 % greater chance of being damaged by a flood over the life of a 30-year mortgage than by fire or other loss. Your homeowner's insurance will typically not cover flood damage.

Because Saginaw Township participates in the NFIP's Community Rating System (CRS), anyone who owns or rents property within Saginaw Township can purchase flood insurance through a licensed local insurance agent at a reduced rate.

#### Filling & Construction Permits

If you are considering grading, filling, building construction or building renovations there are special regulations that may apply to your project. Ray Hausbeck, Building Inspector,

Reoccurring false/unwanted alarms can condition businesses, home owners and firefighters into believing that the next alarm is more than likely going to be false. Below are a few tips you can use at your home and business to prevent these false, unwanted and sometimes embarrassing alarms..

#### **Smoke Alarms**

- Replace the smoke alarm if it is over ten years old.
- Replace the batteries every year.
- Cover smoke alarms during construction to protect them from dust.
- Place smoke alarms away from furnaces, ovens and bathrooms with a shower.

- Police are trained to remain in a position that will enhance officer safety
- Police actions and communications are not intended to offend you

### How should I act if I am stopped by the police?

- Remain calm
- Keep your hands visible
- Wait for the officer's instructions before reaching for anything or moving suddenly
- Remain seated if you are in a vehicle
- If a weapon is nearby tell the officer at the first opportunity

- the fire alarm system into test mode when testing the system during construction.
- Know the difference between a low battery chirp and an alarm.

#### **Carbon Monoxide Alarms**

- Replace carbon monoxide detectors if they are over seven years old.
- Replace the batteries every year.
- Do not place a carbon monoxide alarm in close proximity to a fuel-burning appliance.
- Know the difference between a low battery chirp and an alarm.

#### Cooking

- Clean the stove and oven often to remove grease and food debris.
- Never leave cooking food unattended.

### SAGINAW TOWNSHIP YARD WASTE PROGRAM AND BRUSH DROP OFF SITE 2017



The Yard Waste Program for Saginaw Township will begin Monday, April 3. Yard waste must be in Kraft paper bags or containers (35 gallons or less) marked Yard Waste. Yard Waste stickers are available at the Saginaw Township offices. The Saginaw Township Brush Drop-Off Site will open the second weekend in April. It is located at 5790 W. Michigan, next to the Waste Water Treatment Plant. The site will accept brush and tree trimmings only and nothing larger than 6 inches in diameter. The site is open to Saginaw Township Residents on the following Saturdays and Sundays ONLY from 9 a.m. - 3 p.m.

# **REMOVE MAILBOX BOARDS**



Temporary structures shall be installed/ erected only during winter months and shall be removed by April 1st. These structures shall not obstruct one's view or create a traffic hazard.

### Keeping Up the Master Voter File

Caginaw Township Clerk's Office maintains the voter file Udatabase for all registered voters in the township. In order to maintain accuracy, the Clerk's Office continually updates voter registration records daily by recording people moving in and out of Saginaw Township. In the unfortunate situation of a deceased voter, the Clerk's Office must cancel the voter in the system. Upon notification, we verify that the deceased person was a registered voter before canceling the appropriate record. The Clerk's Office receives notifications or verifications through the following methods:

- Family members may notify the Clerk's Office with name, address, date of birth, and date of the deceased.
- Secretary of State's Office emails a list of deceased voters.
- Mail is returned to the Clerk's Office marked "Deceased".
- Saginaw County Clerk's Office emails list of deceased residents.
- Saginaw Township Clerk's Office checks Obituaries in the newspapers and online.
- Inspectors receive information on Election Day at polling locations.

If you know a loved one that has passed, make sure they are removed from the voter records by notifying the Saginaw Township Clerk's Office at 989-791-9830, Monday through Friday 8 a.m. – 5 p.m. Help keep our records current.
