

DESCRIPTION OF LAND PLATTED.

The land embraced in the annexed plat of the AHRENS ACRES SUBDIVISION, a subdivision of part of the southwest quarter of the south east quarter, Section 16, TION-R4E, Saginaw Township, Saginaw County, Michigan, and described as follows; Beginning at a point on the north and south one quarter line, Section 16, TI2N-R4E,435.6'feet north of south one quarter corner; thence north one degree, 30 minutes east 696.9 feet; thence, south 87 degrees 05 minutes east, 986.9 feet; thence, south 1 degree, 35 minutes west, 360.0 feet; thence, north 87 degrees, 05 minutes west, 329.1 feet; thence, south 1 degree, 42 minutes west, 341.2 feet; thence north 86 degrees, 43 minutes west, 657.0 feet; to point of beginning.
