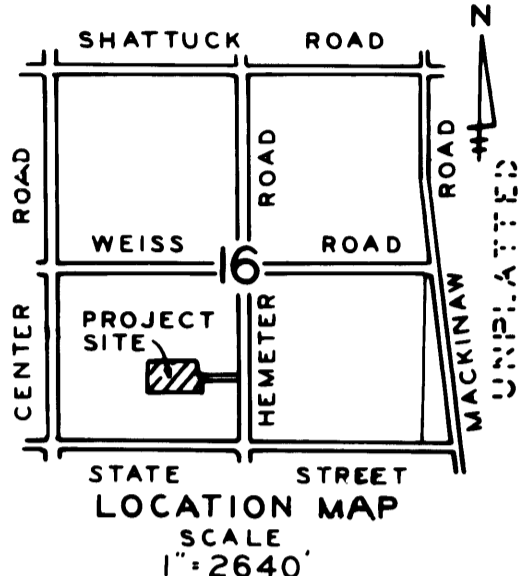

I, ARTHUR H. LEACH, SURVEYOR, CERTIFY:

THAT I HAVE SURVEYED, DIVIDED, AND MAPPED THE LAND SHOWN ON THIS PLAT, DESCRIBED AS FOLLOWS: "DEISLER SUBDIVISION NO. 2", PART OF THE SE 1/4 OF THE SW 1/4, SECTION 16, T12N - R4E, SAGINAW TOWNSHIP, SAGINAW COUNTY, MICHIGAN, COMMENCING AT THE SOUTH 1/4 CORNER OF SECTION 16, T12 - R4E, AND RUNNING THENCE N 0° 19' 30" E - 991.36 FEET ALONG THE NORTH-SOUTH 1/4 LINE OF SECTION 16, THENCE N 88° 13' 30" W - 478.00 FEET ALONG THE SOUTH LINES OF LOTS 5 AND 4 OF "DEISLER SUBDIVISION" RECORDED LIBER 17, PAGES 24 AND 25, TO THE SOUTHWEST CORNER OF LOT 4 BEING A CONCRETE MONUMENT AND POINT OF BEGINNING THENCE CONTINUING N 88° 13' 30" W - 828.10 FEET TO THE WEST 1/8 LINE THENCE N 0° 09' 00" E - 316.94 FEET ALONG THE WEST 1/8 LINE TO THE SOUTH 1/8 LINE AND SOUTHEAST CORNER OF LOT 40, "GOLFDALE MANOR" RECORDED LIBER 10, PAGES 44 AND 45, THENCE S 88° 14' 00" E - 821.06 FEET ALONG THE SOUTH 1/8 LINE, THENCE S 1° 46' 00" W - 178.00 FEET, THENCE S 69° 44' 46" E - 6.29 FEET, THENCE S 88° 14' 00" E - 10.03 FEET TO THE SOUTHWEST CORNER LOT 3, "DEISLER SUBDIVISION", THENCE S 1° 46' 00" W - 136.95 FEET ALONG THE WEST LINE OF "DEISLER SUBDIVISION" TO THE SOUTHWEST CORNER OF LOT 4, "DEISLER SUBDIVISION" WHICH IS THE POINT OF BEGINNING, CONTAINING 7 LOTS, NUMBERED 6 THROUGH 12 INCLUSIVE, CONTAINING 5.99 ACRES, MORE OR LESS.

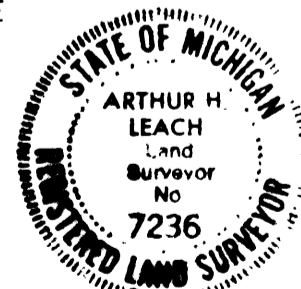
