

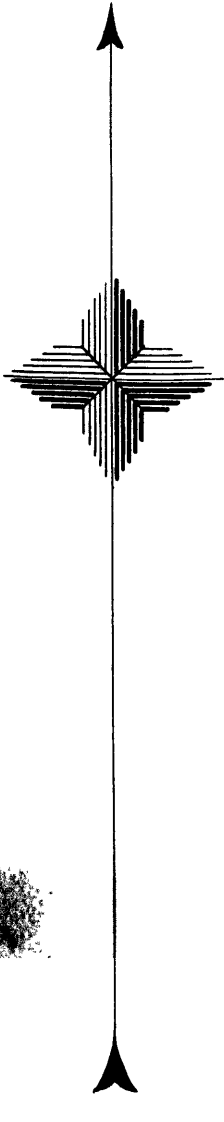

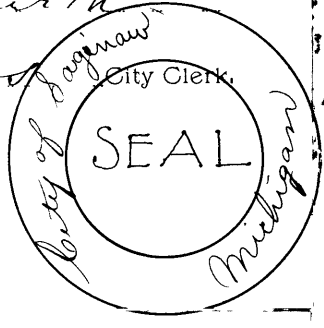

The land embraced in the annexed plat of the Saginaw Improvement Company's Addition G to the City of Saginaw, Michigan, is described as follows: Commencing on the south line of the right of way of the Michigan Central Railroad 207 1/2 feet south of the corner of sections 27, 28, 33 and 34, Township 12 North Range 14 East running thence south 89° 30' West 1312 1/2 feet to subdivision line thence south 1° 05' East along subdivision line 2597 1/2 feet to the quarter line of sections 34, thence North 89° 33' East 1313 1/2 feet to $\frac{1}{4}$ post between sections 33 and 34, thence North 89° 30' East 317 3/8 feet thence North 1° West 2598 3/8 feet to south line of Michigan Central Railroad, thence South 89° 30' West 322 feet, to the place of beginning.

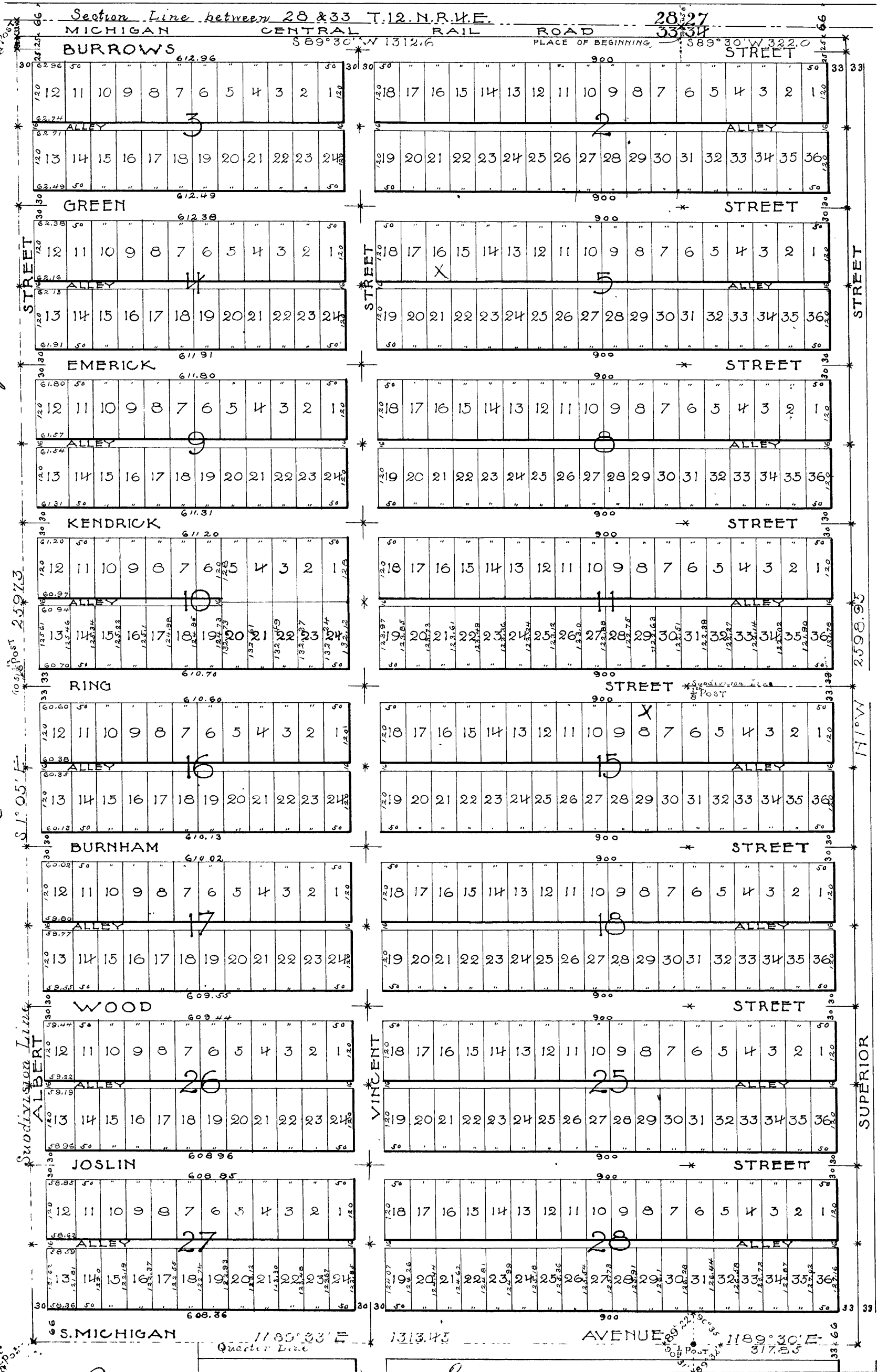
