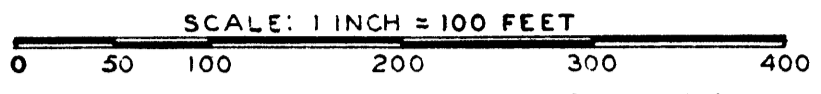

DESCRIPTION

The land embraced in the annexed plat of SCOTTVIEW MANOR, Division One, Section 19 - Township 12 North - Range 4 East, Saginaw Township - Saginaw County - Michigan, is described as follows: Commencing at a point on the East and West $\frac{1}{4}$ line 738.34 feet N.88°-15'-45"W., along said line from the East $\frac{1}{4}$ post of said Section 19; thence S.01°-44'-15"W., 772.65 feet; thence N.88°-23'-20"W., 689.48 feet; thence N.14°-16'-00"W., 120.00 feet; thence N.88°-23'-20"W., 726.00 feet to the center of State Trunkline Highway M-47 also known as Midland Road; thence N.14°-16'-00"W., 587.00 feet to the East and West $\frac{1}{4}$ line of said Section 19; thence S.88°-15'-45"E., along said line 1633.00 feet to the point of beginning. This plat contains 61 lots numbered consecutively from 1 to 61 inclusive.

SURVEYOR'S CERTIFICATE

I hereby certify that the plat herein delineated is a correct one and that permanent metal monuments consisting of bars not less than one-half inch in diameter and 36 inches in length, or shorter bars of not less than one-half inch in diameter lapped over each other at least 6 inches with an over-all length of not less than 36 inches, encased in a concrete cylinder at least 4 inches in diameter and 36 inches in depth have been placed at points marked thus o as thereon shown at all angles in the boundaries of the land platted, at all intersections of streets, at points of curvature and points of tangency in street-lines, and at the intersections of streets with the boundaries of the plat as shown on said plat.

All Roads and Streets are to be graded and drained with necessary drainage structures installed and a roadway surface, which shall consist of crushed stone or natural gravel conforming to Michigan State Highway Department Specifications 21A. The surface shall have a minimum width of 18 feet and a compacted thickness of 6 inches. When crushed stone is used the top 2 inches shall be 21A with screenings added to provide a dense wearing course.
