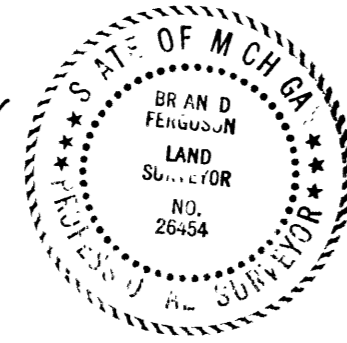


SURVEYOR CERTIFICATE

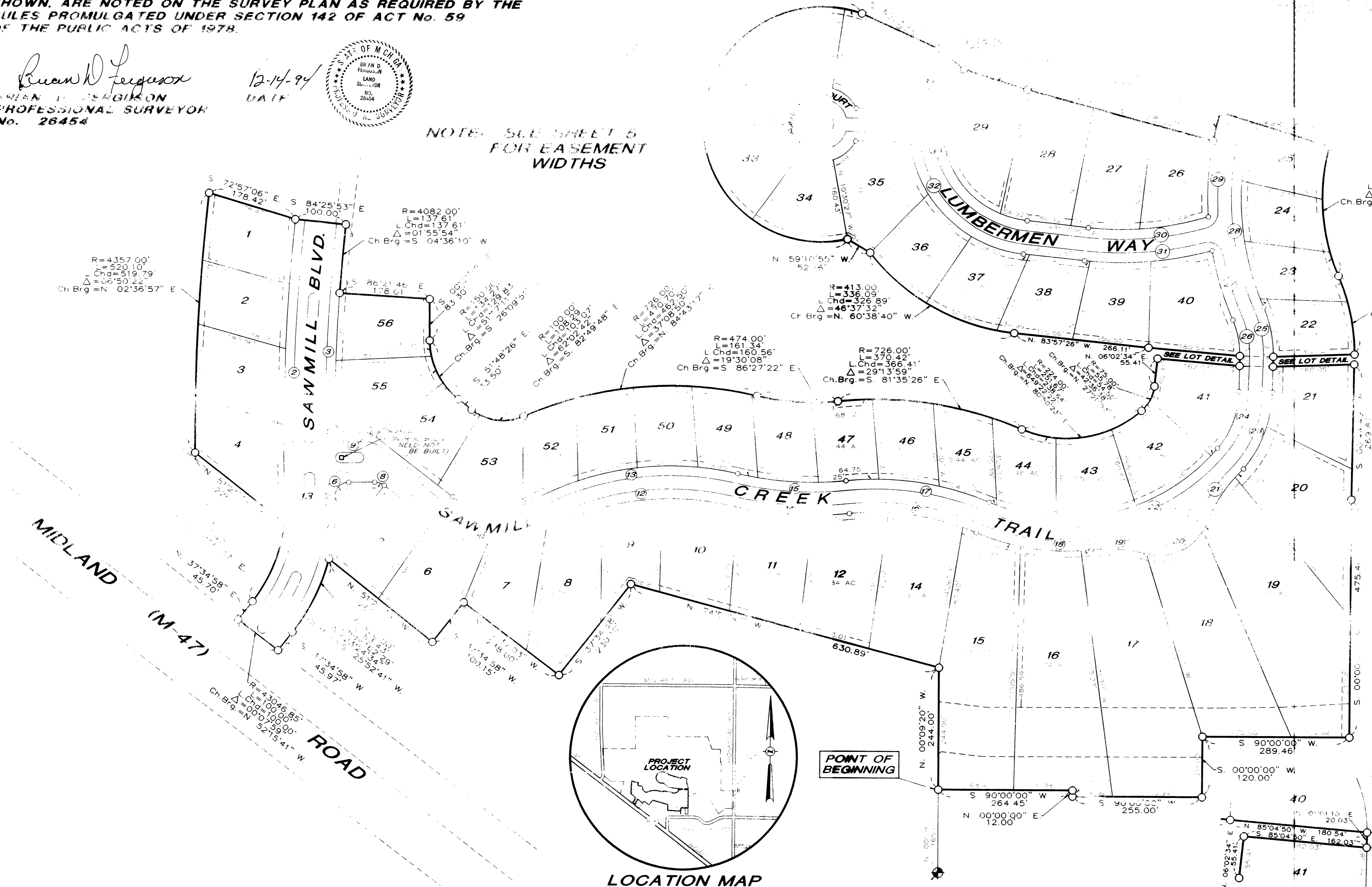

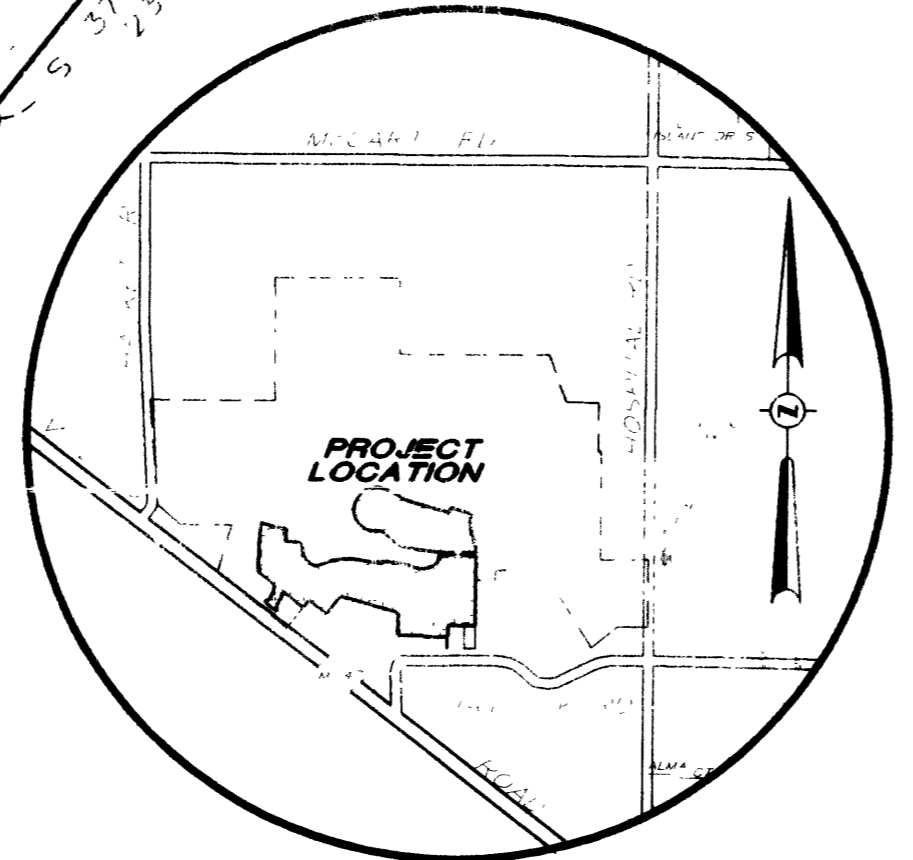

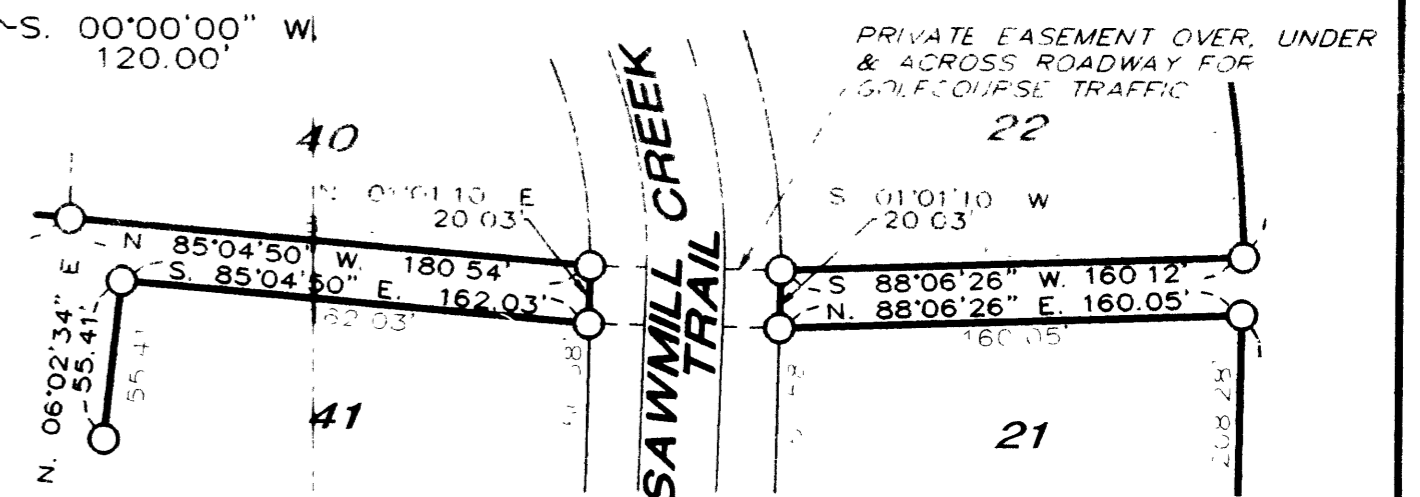
